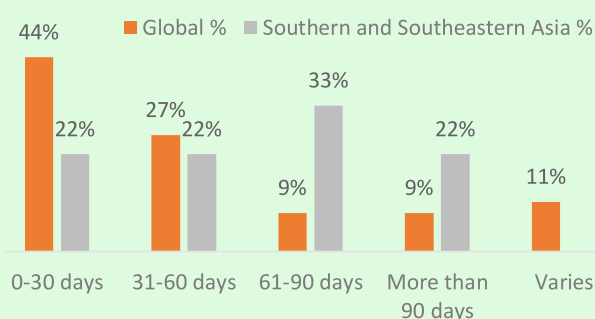


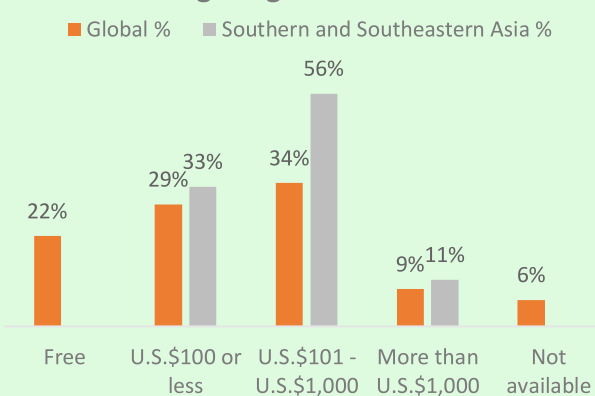

- Top 3 social causes**

The top 3 social causes supported by philanthropic organizations in Southern and Southeastern Asia economies were basic needs, primary through high school education, and human rights.

- #GivingTuesday**

India, Pakistan, and Singapore have joined in the Giving Tuesday movement to celebrate and encourage generosity in their country.

- Giving Pledge signatories**

Individuals from India and Indonesia have joined in the Giving Pledge, committing more than half of their wealth to philanthropy.

- The Companies Act in India**

Companies in India that meet certain financial thresholds are required by law to spend at least 2 percent of the average net profits from the three preceding years on corporate social responsibility.

- Workshop on philanthropy reporting in Pakistan**

An inaugural workshop on philanthropy reporting was held in Pakistan in March 2019 to enhance the effectiveness of media in reporting philanthropic organizations and their work.
